Contract

§ 1 Subject of agreement

The model irrevocably and indefinitely transfers all rights to the photographer to the photographer the use, image processing and publication at the time of the shoot onby the photographers of pictures taken bofy the model.

Any use of the pictures resulting that is likely to damage the reputation of the model or the photographer is generally excluded.

§ 2 Naming

However, naming the real first and last name is only permitted if the model expressly allows / does not allow it. (Strike out what is not applicable). It is agreed with the model to use the following name in publications if it is intended to be for:

§ 3 Rights and obligations

Within 4 weeks after the photos were taken, the model will receive a selection of photographs of the jointly taken and, if necessary, edited pictures from the photographer in digital form. The model may use these photos for personal purposes and self-promotion, e.g. B. Applications, creating a model folder, using your own homepage, sedcards, etc. (also on or in Internet sites, databases or catalogs from model agencies or other third parties) freely and free of charge. The model may also sell the photographs themselves if this serves the purpose of self-portrayal. A transfer of the commercial license is excluded. This settles any further claims of the model.

§ 4 Employment

The model is aware that this agreement does not create an employment contract.

§ 5 Publications / External processing

If suitable, the photographer will include some photos in his own portfolio (Facebook, Instagram, Twitter, Vero, website, etc.).

External processing of the images for publication purposes by the model requires the prior arrangement with the photographer. This is intended to protect the photographer's own artistic image processing and style from falsification.

§6 Majority and full legal capacity

Before the start of the shoot, the model will provide the photographer with proof of age, which proves that the model has reached the age of 18 and hereby declares that it has full legal capacity.

If the model does not meet these requirements, the shooting will not be carried out and/or the data will be deleted immediately.



§ 7 Other agreements

The model will receive a mutually signed copy of this agreement from the photographer. During the shoot, both parties can suggest or reject postures and image ideas.

No other agreements were made. Additional agreements are required to be effective the written form. An accompanying person who is familiar with the model and who is present at the shooting is permitted if required. However, costs for the accompanying person are not covered..

§ 8 Failures / Problems

The model is aware that in the event of non-appearance or cancellation at the agreed date for reasons for which the model is responsible (§276 BGB) for all verifiable expenses already incurred by the photographer for the shoot (e.g. studio rental, fee for make-up artist, travel expenses, costs for accommodation, etc.) will be incurred.

§ 9 Data protection

Written consent according to EU GDPR.

The personal data specified in the contract, in particular name, address, telephone number, date of birth, which is necessary and required solely for the purpose of carrying out the contractual relationship that is being created, is collected on the basis of statutory provisions. This data will not be passed on to third parties without your consent.

Rights of the model: information, correction, deletion and blocking, right of objection According to Article 15 GDPR, the model is entitled at any time to ask the photographer for comprehensive information about the data stored about you.

In accordance with Article 17 GDPR, the model can request the photographer to correct, delete and block individual personal data at any time. The fee paid must then be reimbursed fully.

The model can also make use of your right of objection at any time without giving reasons and change or completely revoke the given declaration of consent with effect for the future. The model can send the revocation to the contractual partner either by post or by e-mail. The fee paid must then be reimbursed fully.
